N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

2024 General Election
Audit Date: November 18, 2024

The Cumberland County Board of Elections (BOE herein) performed an audit consistent with the provisions of N.J.S.A. 19:61-9 and the New Jersey Election Audit Procedures developed by the New Jersey State Division of Elections.

The Cumberland County BOE conducted a hand-to-eye count of the voter-verifiable paper records for the General Election for all offices selected by the Secretary of State. The offices to be audited are that of the President, Senate, House of Representatives, County Clerk, County Commissioners, and Mayor, City Commissioners, or Township Committee as directed by the Division of Elections and Secretary of State Tahesha Way. All other offices were excluded from the audit.

Pursuant to the statute, "Counties having less than 100 election districts shall audit at least two election districts."

There were 597 audit units for the County of Cumberland. Two percent (2%) of 597 batches indicated that twelve (12) batches were required to be audited. A total of twelve (12) batches were audited.

The following audit units were randomly selected:

1. Mail-In Batch 26 Borough of Shiloh District 1
2. Mail-In Batch 2 Bridgeton City Ward 3 District 5
3. Mail-In Batch 20 Hopewell Township District 2
4. Mail-In Batch 4 Bridgeton City Ward 3 District 1
5. Machine ED Vineland City Ward 5 District 5
6. Mail-In Batch 31 Millville City Ward 1 District 3
7. Machine ED Vineland City Ward 3 District 3
8. Mail-In Batch 17 Hopewell Township District 1
9. Provisional Batch 3 Deerfield Township District 1
10. Mail-In Batch 5 Bridgeton City Ward 3 District 4
11. Mail-In Batch 58 Vineland City Ward 5 District 4
12. Mail-In Batch 34 Millville City Ward 5 District 6

In each district, the hand to eye audit was 100% consistent with the scanned tally. Any paper ballot which contained an overvote for a particular contest was recorded as an overvote but did not count as a vote.
