COMMENTS:

From 11/13/24 onward, the Vote by Mail Ballots - Ballots to be Processed was reported as 1,130. That number was the number of Ballots Returned to the Board of Elections that could not be counted as they did not meet the legal qualifications. At this time, all 78,823 timely and eligible Vote by Mail Ballots have been tallied and are indicated above. From 11/15/204 onward, the number of Provisional - Eligible Received was reported as 11,845. That number was actually the total Provisional Ballots issued during Early Voting and Election Day. After the Board of Election's standard investigation/review process, it was determined that of the 11,845 Provisionals issued, 2,320 did not meet the legal qualifications to be counted. At this time all 9,525 Eligible Provisionals have been tallied and are indicated above. There are no outstanding ballots eligible to be counted.
