What's New?

1. The NJHC is increasing the maximum request for eligible projects to **\$25,000** (from \$15,000).

2. Special Concerns for advancing inclusive history are encouraged. They are:

- Native Americans of New Jersey, Past and Present (2021)
- New Jersey and Histories of Immigration/Migration (2022)
- New Jersey and the United States Semiquincentennial (2026–2033)

What's Next?

We are expecting the DOI to be live on [SAGE](#) by the week of February 24th (This is the brief, one-page online form you will submit for the NJHC to determine eligibility).

What Can I Do Now?

1. If you or your organization is not yet registered in [SAGE](#), we recommend that you do so as soon as possible. You will not be able to submit a DOI by March 11th without an account. A link for new users to create and account can be found on the [SAGE homepage](#).
2. READ THE GUIDELINES (above). This will allow you to begin getting information together and get a head start on the full application (e.g. narrative, commitment letters, etc.).
