DOMESTIC SECURITY PREPAREDNESS TASK FORCE

ORDER PURSUANT TO THE NEW
JERSEY DOMESTIC SECURITY
PREPAREDNESS ACT (N.J.S.A.
App. A:9-64 et seq.)

WHEREAS, on October 4, 2001, the Legislature of the State of New Jersey enacted the New Jersey Domestic Security Preparedness Act (hereinafter the "Act"); and

WHEREAS, the Act authorizes and directs the Domestic Security Preparedness Task Force (hereinafter the "Task Force") to provide statewide coordination and supervision of all activities related to domestic preparedness for a terroristic attack by ensuring that there is a comprehensive program of domestic preparedness to prevent, prepare for, respond to, and recover from incidents of terrorism; and

WHEREAS, the Act authorizes and directs the Task Force to identify and assess potential risks to the domestic security and the well-being of New Jersey's citizens, including risks to and disruptions of essential State and local infrastructures and transportation networks; and

WHEREAS, the Legislature having recognized the importance of the private sector in assisting the Task Force to fulfill its mission and obligations under the Act, the Act directs the Task Force to establish an Infrastructure Advisory Committee (hereinafter the "IAC") to assist the Task Force; and

WHEREAS, in response to the efforts of the Task Force and the IAC to preserve, protect, and sustain domestic security, many owners and/or operators of New Jersey's essential public and private infrastructure sites have engaged in projects and developed plans that implement the "best practices" to better secure and protect their respective sites; and

WHEREAS, the Task Force having determined that in order to preserve, protect, and sustain domestic security in this State, there is an urgent need to implement heightened security measures at aeronautical facilities licensed by the State of New Jersey; and

WHEREAS, your facility has been identified as an aeronautical facility licensed by the State of New Jersey;

ACCORDINGLY, consistent with the mandate of the Legislature and as authorized and directed by the Act,

IT IS on this *21* day of *March*, 2003,

ORDERED that your facility shall implement the following security measures:


1. The requirement that all aircraft which are parked or stored at the aeronautical facility for more than a 24-hour period utilize a two-lock system which secures or disables the aircraft to prevent operation of the aircraft.
2. The posting of prominent signage at your facility which shows the telephone number(s) and radio contact information for the facility owner or operator, police and other emergency responders, New Jersey State Police, NJDOT Division of Aeronautics, FAA, TSA, and NTSB.

IT IS FURTHER ORDERED that your facility shall certify in writing to the Director, Division of Aeronautics, Department of Transportation, P.O. Box 610, Trenton, NJ 08625-0610 or by telefax at 609-530-4549 within seven (7) calendar days from the date of this Order that it has implemented the security measures specified above; and it is further

ORDERED that failure to comply with the requirements of this Order or failure to certify compliance within seven (7) calendar days shall subject you and/or your facility to fines, suspension, and/or revocation of license pursuant to the provisions of N.J.S.A. Title 6.
