The Project

New Jersey Department of Transportation (NJDOT) is proposing intersection improvements in the greater Hackettstown area. The project consists of four sites:

Site 1: Intersection of Route 46 (MP 21.25) and High St /Grand Ave (Hackettstown)

Site 2: Intersection of Route 46 (MP 21.70), Route 182 (MP 0.96), Warren St and Willow Grove St (Hackettstown)

Site 3: Intersection of Route 46 (MP 22.18) and East Ave (Mt. Olive Township & Washington Township)

Site 4: Intersection of Route 57 (MP 21.10) and Route 182 (MP 0.00) (Hackettstown)

The purpose of the project is to relieve/reduce congestion and improve mobility at the four selected locations. The site locations were selected from the Department's Congestion Management System, which ranked the four sites as highly congested. This project is nearing completion of the Preliminary Engineering phase and will shortly move into Final Design. Specifically, the project improvements include:

Site 1:

- Northwest corner cutback to improve alignment and turning movements
- NJDOT signal relocations and upgrades, ADA ramp improvements
- Pavement Resurfacing

Site 2:

- Traffic signal re-timing and upgrades, ADA ramp improvements
- Pavement Resurfacing

Site 3:

- Southeast corner cutback to improve turning movements
- Utility Pole Relocation
- Signal Timing upgrade, including East Ave right-turn overlap phase
- NJDOT signal relocations and upgrades, ADA ramp improvements
- Concrete sidewalk along Route 46 Eastbound, connecting existing sidewalk to East Ave intersection
- Pavement Resurfacing

Site 4:

- Re-stripe intersection to allow double left-turn from Route 57 to Route 182
- NJDOT signal re-timing, relocations and upgrades, ADA ramp improvements
- Pavement Resurfacing

Complete Final Design:	December 2020
Start Construction:	March 2021
End Construction:	May 2022
