

ROUTE 52 CAUSEWAY REPLACEMENT PROJECT COMMUNITY PARTNERING TEAM MEETING NO. 2 REPORT

DATE: March 26, 2003

TIME: 10:00 a.m. - 3:00 p.m.

LOCATION: Mac's Restaurant, Somers Point, NJ

1. PURPOSE OF MEETING

To present the results of the Task Force Meetings; to discuss the project status and proposed improvements; and to discuss community issues and next steps for public outreach. (Agenda and PowerPoint Presentation Slides attached)

2. MEETING SUMMARY

Martine Culbertson, opened the meeting on behalf of the New Jersey Department of Transportation. Participants then introduced themselves and who they represent. Martine reviewed the agenda and explained the materials distributed for their CPT Handbooks. She then introduced Mike Sidani, the Project Manager from the engineering firm Michael Baker, Jr. to present the project status.

Project Status:

Mike Sidiani began by presenting the sequence of events since the first CPT meeting. He reviewed the CPT Team Charter, the five Task Forces and their respective goals. (See powerpoint presentation attachment.) Mike then noted the modifications to the IPA (Initially Preferred Alternative) as a result of the input from the first CPT meeting and the task force meeting discussions. the CPT requested revised conceptual drawings and maps for the CPT Handbook. Mike introduced Fred Gottemoeller to present the conceptual drawings for the causeway aesthetics, visitors center and gateway areas for Somers Point and Ocean City.

Causeway Aesthetics and Visitors Center:

Fred Gottemoeller reviewed the guiding principles for aesthetic design elements (see powerpoint presentation attachment). He emphasized the conceptual visual theme for the causeway as a "ribbon in space". Given the guiding principals and proposed bridge design, there are two options to consider for the piers: (1) fan approach at top of pier or (2) octagonal shape column. There are two types of open railing to consider: (1) modern vertical rails or (2) more historic railing similar to porches in the area. Fred presented three lighting options: (1) single center roadway lighting emphasizing points of light concept, (2) underdeck superstructure lighting and (3) pier lighting.

There is a fourth alternative being developed that combines points of light concept along with the pier lighting. Fred reviewed the Ocean City Visitors Center renderings and the MacArthur Boulevard area widening with a landscaped median in one area and the serpentine sidewalk. He also presented the aesthetic concepts for the Ocean City gateway area and the Somers Point gateway area (see attached powerpoint presentation and artist renderings).

Questions were raised as follows:

- Q Who is responsible for maintenance of the proposed picnic and parking area near the Somers Mansion Site?
- A A jurisdictional agreement would be drafted indicating that Somers Point would be responsible for maintenance once constructed by the State.
- Q Landscaping has been shown for the Mansion site. What will the landscaping look like at the other locations around the Somers Point circle.
- A NJDOT will continue to work with the local community in refining the aesthetic treatments and show the improvements from each perspective.
- Q- Will utilities be taken down or put underground?
- A The location of utilities will be determined once final design is completed. The movement of utilities lines is considered a betterment, so such an enhancement would have to be examined for benefits and costs. The costs for betterment would have to be borne by the City of Somers Point.

Mobility, Circulation and Access:

Tim Lidiak presented the modifications to the design pretaining to access and circulation issues in Somers Point. MacArthur Boulevard changes are proposed to create a right angle intersection at Braddock Avenue. As a result, the Casual Furniture store's parking lot will be altered. Additionally, Tim reviewed the access flow for each of the businesses around the Somers Point circle namely, Joe's cafe, Point Diner, Circle Liquor, Passport Inn, and Crab Trap. He explained the displacement and relocation of parking spaces at each of the properties and the inclusion of shared access between businesses to improve access.

Tim presented the circluation and access for Ocean City. An issue was raised regarding the proposed take of one condo unit at the Bridgeport Plaza Condominiums in order to accomodate a suggested sidewalk on the south side of the causeway on to 9th Street. It is possible to remove the one unit and have the other units to remain intact. The owners of the end unit proposed to be removed were present at the meeting and expressed strong desire to stay in their current location. Further evaluation is underway. Tim explained the bike connectivity to the regional bike trails on both sides of the causeway. He also spoke of fishing access on Rainbow Island and bumps outs on the causeway. He closed explaining the need for traffic calming techniques to allow pedestrian and cyclists to cross at busy interections.

CPT Discussions over Lunch:

The CPT moved to round tables for lunch and discussion on the causeway aesthetics. Each table was asked to discuss the options for the design for the piers, railings, and lighting. In returning to the presentation room, Martine asked for input on the aesthetic elements. The results are as follows:

- Octagonal straight piers preferred over fan piers.
- Historic patterned railing preferred over the straight railing provided the views are not obstructed.
- Center roadway lighting appearing as a "string of pearls" preferred to lighting of the piers and understructure.
- As a side discussion, the owners of the Chinese Restaurant showed up and expressed their desire to stay in their current location.

Traffic Staging and Management:

Al Klag presented the staging of the bridge. The will be two lanes of traffic in both directions through out the project during the peak summer seasons, and during the off season phase, traffic could be one lane in each direction as needed. This task force will be active in providing traffic management plans and coordination throughout the various stages and phases of construction. Traffic signal timing will be examined under current conditions and adjusted at appropriate times to assist in efficient flow of traffic during construction staging. Devices will be used to provide early warning to motorists such as radio announcements, VMS signs, and an evacuation plan

Public Infortmation and Awareness:

Bill Felix reviewed the guiding principals for public information and awareness. He emphasized the importance of community outreach with effective communication. The web site will provide current information on the project including meeting reports and a mechanism for submitting public comments and questions. There will be Public Officials Meetings and Public Information Center Meetings to be held in the upcoming months. This task force will continue to work on getting the word out through press releases, TV, informational flyers, and local newsletters. A concern was raised that the public meetings held during the week make it difficult for the summertime residents to attend. It was suggested to consider hosting a Friday evening or weekend public meeting to obtain comments from the sector of the public. Tony Marsella noted that written comments on the proposed improvements can be submitted at anytime. There is a thirty day comment period after the plublic meeting in which written comments mailed to NJDOT will be addressed and there is a formal process for providing responses to comments for any written comment submitted within thirty days of the public meeting. Environmental Process:

Marshall explained that the environmental process is a continuation of the EIS mitigation from the historic impacts. Fishing access on Rainbow Island and at the Visitors Center have been coordinated with DEP as well as protection of species. The project team will be meeting with permitting agencies and applying for permits over thenext 90 days.

Community Input:

Martine asked CPT members to provide input on the task force information presented or other issues. The following comments were noted on newsprint:

- Access to fishing along bridge
- Boating
- Privacy issue of neighborhoods visual and lighting
- Privacy screens
- Parking lot configurations
- Fishing pier how far out for efficient use
- Boating speeds
- Connecting of bike paths Shore Rd. needs more examination AI

- Screening issue
- Lighting more lights out there, more maintenance
- Lighting sensitivity for residents
- Vibration monitoring and control
- Consistent and constant information (fear what they don't know)
- Concern for Palen Road with 9th Street due to sight distance better configuration for parking spaces on other side of roadway
- Signage directional and standard signs, regulations and aesthetics AI
- Homeland security to be addressed, maintenance and cost efficiency
- Examine maintenance of lighting, and railing AI NJDOT
- Provide updated maps for CPT Handbooks
- 900 block Palen Road is often under water needs to examine storm drains AI
- Consistent information for both communities is important
- Property impacts
- Review stakeholders for representation on the CPT
- Maintanence of recreational areas
- Sidewalk illumination

Meeting Schedule:

Regarding the meeting schedule, Mike Sidani noted the next step will be for the Steering Committee to hold a meeting for preparation of the local officials briefing and public information center meetings. The final design will be presented to the public for comment in the spring at a Public Information Center meetings. There will be an additional meeting of the CPT to present results of the public meetings and to review the project status.

In summary, Martine asked members to sign sheets which indicate support for the Team Charter. It will be displayed at the public meetings with additional information on the Community Partnering Team and its accomplishments and on-going outreach efforts. A meeting report will be distributed with a revised list of the CPT members, Task Force members, and revised maps and conceptual drawings.
