This letter is in response to your request, received by the Division of Land Use Regulation (Division) on May 9, 2025, to modify an existing Flood Hazard Area Individual Permit under (File No.: 0406-18-0002.1 LUP230001), which was approved by the Division on October 11, 2023. The original permit authorized the removal of an existing material storage shed and construction of a new materials storage bin, in addition to the restoration of the regulated bank and channel associated with an unnamed tributary to the Great Egg Harbor River.

The proposed modifications to the authorized activities are as follows:

The installation of a 29" x 45" elliptical pipe in lieu of the previously approved 36" x 60" elliptical pipe, of equivalent length approved under the original permit.

All remaining conditions of the original permit remain in effect for the duration of the approval.
