The New Jersey Department of Environmental Protection (NJDEP) issued a Freshwater Wetlands Individual Permit and Flood Hazard Area Individual Permit, for the above referenced project on October 26, 2009 (1810-09-0003.1, FWW090001, FHA090002). You have requested that the Freshwater Wetlands Individual Permit be extended in accordance with the requirements at N.J.A.C. 7:7A-14.6.

LIMIT OF AUTHORIZED DISTURBANCE

The drawings approved are one hundred and fifty seven sheets collectively entitled,

“ROUTE U.S. 206 (1990) BYPASS SECTION 14A & 15A; FROM THE VICINITY OF EXISTING ROUTE U.S. 206 OVER PIKE RUN TO TRIANGLE ROAD EXTENSION; CONTRACT NO. 062960597; NJDEP FRESHWATER WETLANDS INDIVIDUAL PERMIT APPLICATION PLANS”, prepared by Eric Boschen of Dewberry-Goodkind, Inc., dated March 18, 2009, revised as noted below,

- NJDEP Freshwater Wetlands Permit Application Plans, Sheets 14 and 74 of 157, last revised 8/04/09.
- NJDEP Freshwater Wetlands Permit Application Plans, Sheets 1, 8, 30, 31, 32, 58 and 59 of 157, last revised 9/18/09.
- Details and Typical Sections, Sheet 77 of 157, last revised 9/01/09.

The plans authorize the permanent disturbance of 3.785 acres of freshwater wetlands, 10.989 acres of freshwater wetland transition areas and 0.315 of an acre of State Open Waters. The plans also authorize the temporary disturbance of 0.553 of an acre of freshwater wetlands, 1.890 of an acre of freshwater wetland transition areas, and 0.221 of an acre of State Open Waters in order to construct the U.S. Route 206 By Pass and associated ramps, local roadways, and stormwater management improvements within the Township of Hillsborough, Somerset County, New Jersey.


The Division of Land Use Regulation hereby extends the term of the original authorization for a Freshwater Wetlands Individual Permit to **October 26, 2019**.

Any additional disturbance of freshwater wetlands, State open waters, or transition area shall be considered a violation of the Freshwater Wetlands Protection Act unless the activity is exempt or a permit is obtained prior to the start of the disturbance from the Division of Land Use Regulation.

In accordance with N.J.A.C. 7:7A-1.7, any person who is aggrieved by this decision may request a hearing within 30 days after notice of the decision is published in the DEP Bulletin by writing to: New Jersey Department of Environmental Protection, Office of Legal Affairs, Attention: Adjudicatory Hearing Requests, 401 East State Street, P.O. Box 402, Trenton, NJ 08625-0402. This request must include a completed copy of the Administrative Hearing Request Checklist. If a person submits the hearing request after this time, the Department shall deny the request. The DEP bulletin is available through the Department's website at www.state.nj.us/dep.

This letter of extension shall be attached to the previous permit. In addition, please be advised that all conditions of the original permit remain in effect.
