



Restricting Foreign Drones (Effective Dec 22, 2025)

Nature of Issue(s):

Effective December 22, 2025, the American Security Drone Act of 2023 (ASDA) and OMB Memorandum M-26-02 strictly prohibit the use of federal funds for UAS manufactured by "covered foreign entities". "Covered UAS" includes any aircraft, flight controller, camera, or ground control station supplied by a manufacturer that is based in, or subject to the control of, a foreign adversary country, specifically the People's Republic of China. Popular manufacturers such as DJI and Autel Robotics are on the prohibited list.

Contractors must cease their operation, maintenance, or data processing on any FHWA funded project or grant with any covered UAS drones in their existing fleet.

Recommendation(s):

1. All contractors and/or consultants must ensure no pending orders for this equipment will be paid for with federal funds.
2. If existing fleet includes these covered UAS, the contractors and/or consultants must cease their operation, maintenance, or data processing on any FHWA funded project or grant.
3. It is recommended that contractors and/or consultants physically quarantine these devices to prevent accidental use on federally funded projects.

Subject: Important Notice Regarding the American Security Drone Act of 2023 (ASDA) and OMB Memorandum M-26-02 on Restricting Foreign Drones (Effective Dec 22, 2025)

The Bureau of Aeronautics is writing to inform you about significant changes that will impact the use of federal funds for Unmanned Aircraft Systems (UAS). Effective December 22, 2025, the American Security Drone Act of 2023 (ASDA) and OMB Memorandum M-26-02 will strictly prohibit the use of federal funds for UAS manufactured by covered foreign entities.

What All Contractors and Consultants Need to Know:

The Ban: You may no longer use Federal Highway Administration (FHWA) funds (including grants, loans, or cooperative agreements) to procure, operate, or maintain "covered UAS."

What is "Covered UAS": This includes any aircraft, flight controller, camera, or ground control station supplied by a manufacturer that is based in, or subject to the control of, a foreign adversary country, specifically the People's Republic of China. Popular manufacturers such as DJI and Autel Robotics are on the prohibited list.

Required Actions:

1. **Stop Procurements:** The contractors and/or consultants must ensure no pending orders for this equipment will be paid for with federal funds.
2. **Cease Operations:** If existing fleet includes these covered UAS, the contractors and/or consultants must cease their operation, maintenance, or data processing on any FHWA funded project or grant.
3. **Segregate Assets:** It is recommended that contractors and/or consultants physically quarantine these devices to prevent accidental use on federally funded projects.

It is the responsibility of all Contractors and Consultants working on federal projects to take immediate action to comply with these new regulations. Failure to do so may result in non-compliance with federal funding requirements.
