#### **JOB DESCRIPTION**

The Division of Revenue and Enterprise Services is seeking a Network Administrator 1 under the limited supervision of a supervisory official, in a state department, institution, or agency, or in a local government agency, performs complex professional work which includes development, implementation, and maintenance of multi-network, multi-user Local Area Networks (LAN), Metropolitan Area Networks (MAN), and/or Wide Area Networks (WAN); maintains centralized, decentralized, and remote network services; maintains network security and data integrity; provides consultations and recommendations to infrastructure managers, as required, to troubleshoot and resolve network problems, monitor overall performance, and conduct upgrades as required; may be assigned to the administration of Storage Area Networks (SANs); does other related duties as required.

Function as DORES network expert to address all network related projects for the Department. Handle space planning requests involving wiring and various other network related functions. Support (11) Treasury Clients Extranet Connections with Extranet Partners (vendors). Act as Technical Liaison with the Office of Information Technology (OIT) for all that is network-related. Report problems in regards to any environmental issues in the computer room and building telecom rooms.

Coordinate VOIP roll-outs; assist Treasury clients with Call Center projects and other various network related projects. Learn the general layout of the GSN and Treasury Network. Manage the Uninterrupted Power Sources (UPS) that include both standalone and system UPS in the various Treasury occupied buildings. Prepare and submit firewall rules to OIT as needed for various access for applications and systems.

Prepare Tenant Service Requests for power and CAT 6/6A wiring within Treasury occupied buildings. Review and keep upto-date on various floor plans for network access. Assist with any network-related Wi-Fi issues. Act as the Change Management Coordinator for DORES by coordinating and communicating changes implemented by both DORES and OIT. Hold Change Management meetings with DORES staff.

Attend OIT Change Management meetings and advise DORES staff and clients of IT environment changes and downtimes for these changes. Communicate Change Management changes and outages to DORES senior management, staff and clients.

The standard workweek is Monday through Friday. This position <u>may</u> be eligible to participate in the Department's pilot telework program, which allows eligible employees to work remotely for up to two (2) days per week, as approved by management. The position offers a comprehensive benefits package including medical, prescription drug, and dental coverage, benefit leave, Pension, supplemental pension plan, tax saving programs, and paid holidays.

### POSITION REQUIREMENTS

Education & Experience:

Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Seven (7) years of professional experience in the development, implementation, and maintenance of multi-network, multi-user Local Area Network (LAN), Metropolitan Area Network (MAN), and/or Wide Area Network (WAN) environments, including or supplemented by a minimum of eighteen (18) semester hour credits in mathematics, computer science, information technology, and/or computer information systems.

Note:

For positions involved in the administration of a Storage Area Network (SN) applicants must have at least three (3) years of professional experience installing, configuring, and supporting network hardware and software, one (1) year of which shall have been in planning, implementation, and support of SAN and related technologies.

-OR-

Possession of a bachelor's degree from an accredited college or university including or supplemented by a minimum of eighteen (18) semester hour credits in mathematics, computer science, information technology, and/or computer information systems; and three (3) years of the above-mentioned professional experience.

Note:

Evidence of formal training in Computer Science or Information Technology received from or evaluated by an accredited institution of higher learning may be submitted with your application. Applicants must provide documentation from the accredited institution that clearly outlines the training course(s) that are acceptable and the corresponding number of credit hours for the training to be accepted. In-house courses (such as training provided on the job or through the appointing authority) will not be accepted.

Note:

"Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.
