The New Jersey Department of the Treasury, Division of Revenue and Enterprise Services is seeking a Network Administrator 2. Under the close supervision of a supervisory official, in a state department, institution, or agency, or in a local government agency, performs highly complex professional work which includes development, implementation, and maintenance of multi-network, multi-user Local Area Networks (LAN), Metropolitan Area Networks (MAN), and/or Wide Area Networks (WAN); maintains and/or takes the lead on maintenance of centralized, decentralized, and remote network services; maintains and/or takes the lead on maintenance of network security and data integrity; provides and/or takes the lead on providing consultations and recommendations to infrastructure managers, as required, to troubleshoot and resolve network problems, monitor overall performance, and conduct upgrades as required; takes the lead on planning upgrades, capacity, and communication requirements; does other related duties as required.

Administer and monitor DORES supported UNIX servers including AIX and Red Hat Linux ones. Lead the administration of operating system upgrades and patch management for supported Unix servers. Back up the administrator of the Content Management OnDemand (CMOD) system. Implement and oversee special projects for various DORES supported Treasury Divisions in relation to Unix environments. Provide support the administrators of the applications running on the DORES supported Unix servers to resolve issues. Provide second level Help Desk support by responding to client service calls, assessing problems and initiating appropriate actions to solve the problems. Act as backup to monitor account management request notifications. Coordinates resources to troubleshoot/resolve Treasury IT related issues for the Unix server environment. Reviews and responds appropriately to errors logged by Unix servers. Work with vendor support as required. Act as liaison with the Office of Information Technology (OIT). Establish and maintains accurate control records and documentation.

The standard workweek is Monday through Friday. This position **may** be eligible to participate in the Department's telework program, which allows eligible employees to work remotely for up to two (2) days per week, as approved by management. The position offers a comprehensive benefits package including medical, prescription drug, and dental coverage, benefit leave, paid holidays, Pension, supplemental pension plan options, and tax saving programs. POSITION REQUIREMENTS

Education & Experience:

Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Eight (8) years of professional experience in the development, implementation, and maintenance of multi-network, multi-user Local Area Network (LAN), Metropolitan Area Network (MAN), and/or Wide Area Network (WAN) environments, including or supplemented by a minimum of eighteen (18) semester hour credits in mathematics, computer science, information technology, and/or computer information systems.

-OR-

Possession of a bachelor's degree from an accredited college or university including or supplemented by a minimum of eighteen (18) semester hour credits in mathematics, computer science, information technology, and/or computer information systems; and four (4) years of the above-mentioned professional experience.

Note:

Evidence of formal training in Computer Science or Information Technology received from or evaluated by an accredited institution of higher learning may be submitted with your application. Applicants must provide documentation from the accredited institution that clearly outlines the training course(s) that are acceptable and the corresponding number of credit hours for the training to be accepted. In-house courses (such as training provided on the job or through the appointing authority) will not be accepted.

Note:

"Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.
