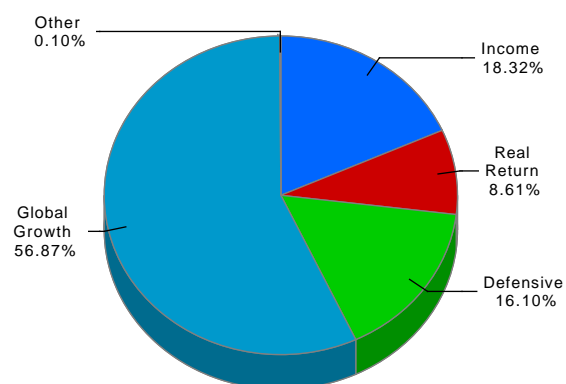

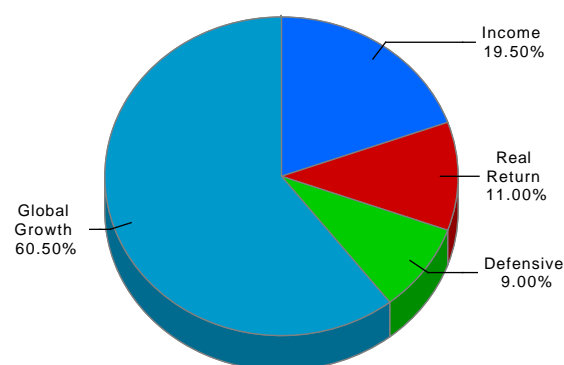

**Current Asset Allocation**



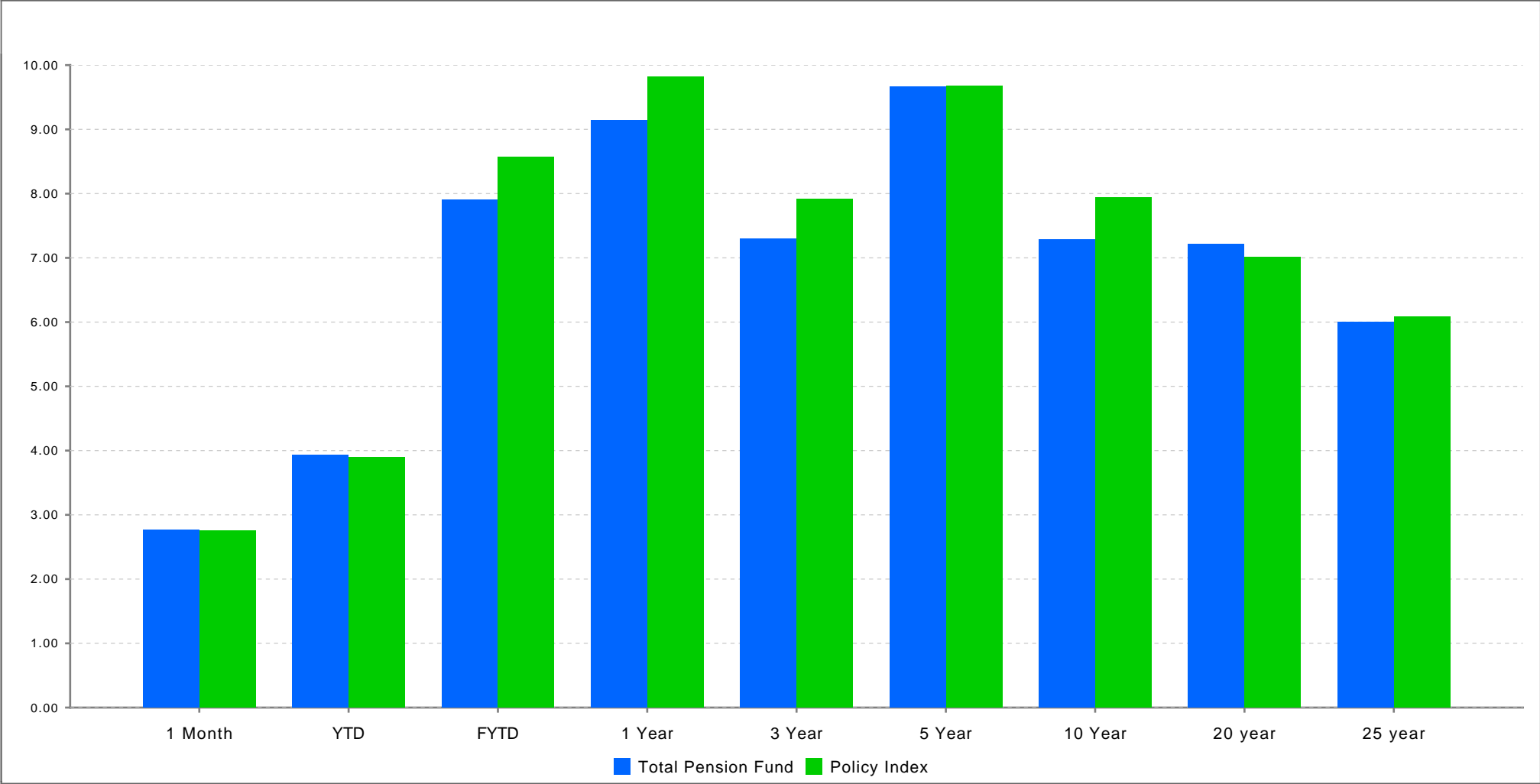
**Target Asset Allocation**

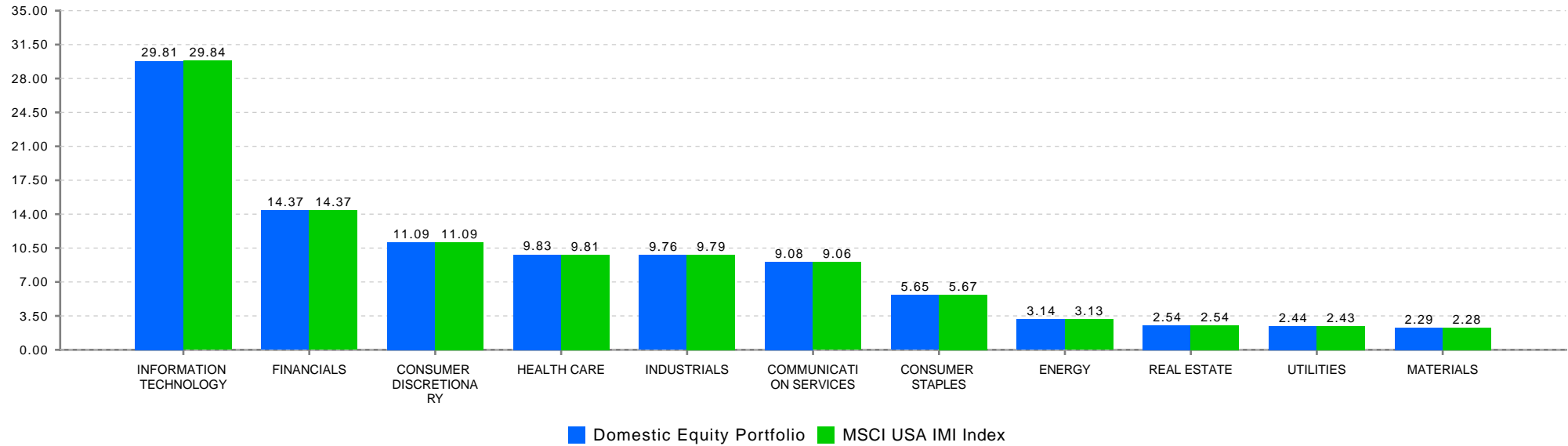

Sector Weightings\*\*



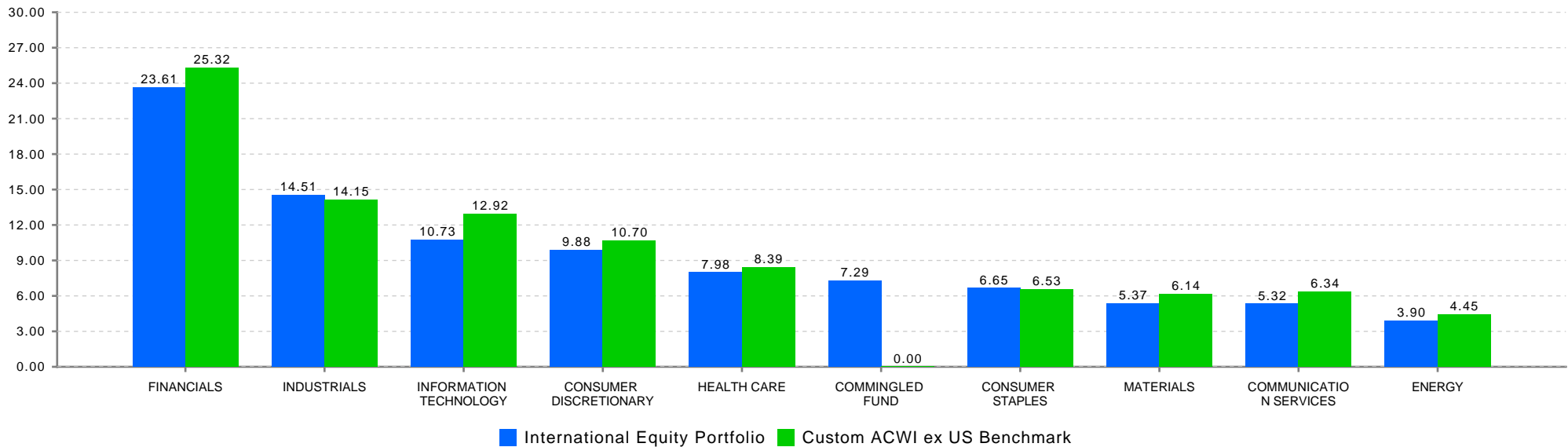

International Equity**



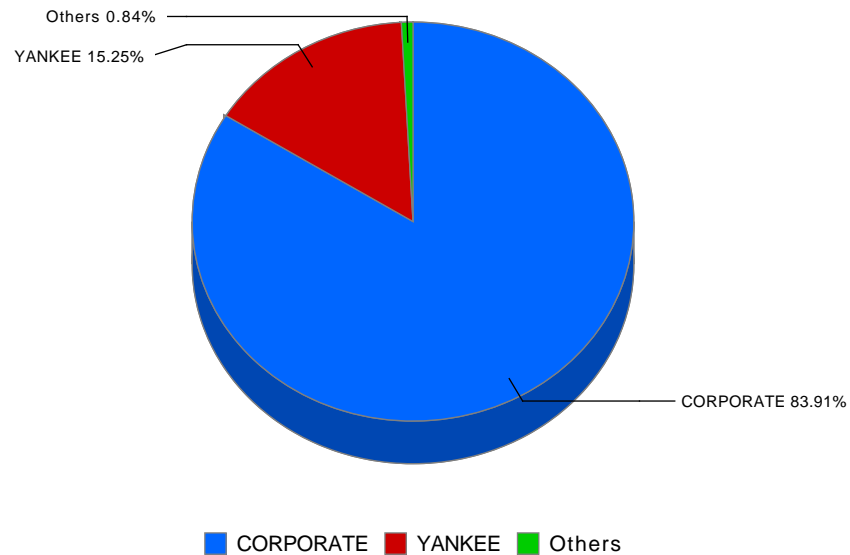

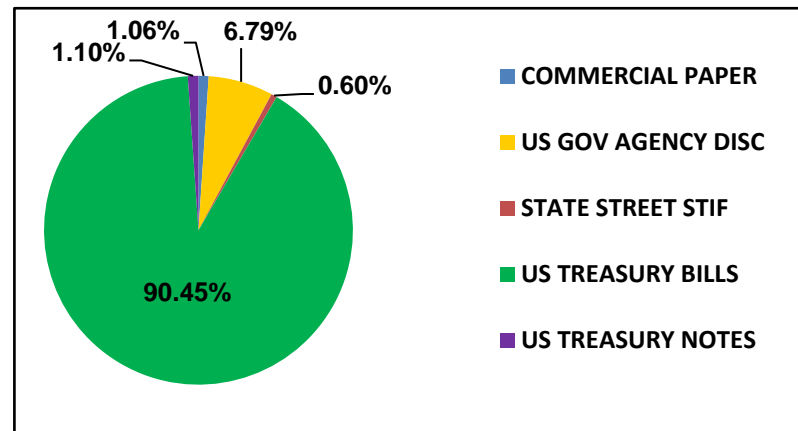
