***Project #:* SPR 24-1560**

***Department:* Corrections**

***Division:* State Parole Board**

***Approximate Size:* 9,400-10,000 square feet of office space.**

***Lease Term:* Proposals must be for a ten (10) year initial lease term, with two (2) DPMC controlled five (5) year renewal options.**

***Parking:* There must be convenient access to at least (46) parking spaces for employee and visitors use. Parole shall need overnight parking for (16) State Vehicles. All parking slots must be lighted and must be located no further than 0.25 mile walking distance from the building/office entrance. Adequate number of barrier-free parking slots are to be provided in compliance with ADA and any other local barrier-free regulations.**

***Special Requirements:* Space shall be located on first floor of building with separate entrance/exit on different side than main entrance and hidden from public.**

Public transportation, a bus stop or other form of public transportation is required to be within a 1/2 mile from the main entrance of the proposed building and the route between the bus stop and the proposed building must allow for easy and safe walking.

***Catchment Area:* Newark, East Orange, Orange, Bloomfield or Montclair in Essex County.**
