- THE MINORITY PERCENTAGE GOAL REQUIREMENT FOR THIS CONTRACT IS 10% PER SKILLED CRAFT.

- THE FEMALE PERCENTAGE GOAL REQUIREMENT FOR THIS CONTRACT IS 6.9% PER SKILLED CRAFT.
