FY24 Pathways to Removing Obstacles to Housing (PRO Housing)

Funding Agency: U.S. Department of Housing and Urban Development

Purpose: Under this NOFO, HUD will provide PRO Housing grants to identify and

remove barriers to affordable housing production and preservation. Eligibility: Others; state, city, township and county governments.

Funding: \$100,064,100; awards up to \$7,000,000

Deadline: 10/15/24

DFC Support Program National Community Anti-Drug Coalition Institute

Funding Agency: Office of National Drug Control Policy

Purpose: The goal of substance use prevention efforts is to prevent and/or delay the first use of substances. Research shows that early age of onset is an important predictor for the development of a substance use disorder later in life. Further, research shows that prevention interventions can have positive longterm effects in reducing substance use.

Eligibility: Nonprofits with 501(c)(3) status, other than institutions of higher

education

Funding: awards up to \$2,500,000

FY24 National Urban Search and Rescue Response System Readiness **Cooperative Agreement**

Funding Agency: U.S. Department of Homeland Security

Purpose: To provide funding to ensure adequate management, training, exercise, procurement and storage and maintenance for the 28 national task forces staffed and equipped to assist State and local governments, to conduct around-the-clock search-and-rescue operations following a Presidentially declared major disaster or emergency under the Stafford Act (e.g., earthquakes,

Landscape Scale Restoration Grant Program 2025 Northeast and Midwest

Funding Agency: Department of Agriculture

Purpose: To encourage collaborative, science-based restoration of priority rural forest landscapes. This program supports high impact projects that lead to measurable outcomes on the landscape, leverage public and private resources, and further priorities identified in each State Forest Action Plan or equivalent restoration strategy.

Eligibility: state, county, city, township and special district governments, nonprofits with or without a 501(c)(3) status with the IRS, private, public and state controlled institutions of higher education.

Funding: awards up to \$600,000

HUD Expands Access to Housing for Veterans

August 8, 2024 - U.S. Department of Housing and Urban Development awarded \$20 million available for additional administrative fee funding to 245 public housing agencies in 43 states currently administering HUD-VASH. With this funding, PHAs are encouraged to expand their housing search assistance to support veterans, expand landlord recruitment for the program, offer incentives and retention payments, help veterans with security deposits, and provide landlord-tenant mediation activities. New Jersey listed among awardees.
