## **Division of Taxation to Offer Extended Hours As April 15 Filing Deadline Approaches**

TRENTON – State Treasurer David Rousseau today reminded taxpayers that all individual income tax returns and payments for 2007 must be postmarked or electronically submitted by Tuesday, April 15, 2008, in order to avoid penalties and interest.

The Treasurer encouraged taxpayers who have not yet submitted their New Jersey returns to file electronically using New Jersey’s “FastFile” options: NJ WebFile or NJ E-File. These easy-to-use systems enable taxpayers to submit paperless returns via the Internet or through the use of a computer software package.

“If you want your income tax refund quickly, the best thing to do is to file electronically,” Treasurer Rousseau said. Electronic filing offers taxpayers a fast, convenient and user-friendly alternative to completing and mailing a paper form. Electronic filers can also opt to have their refunds directly deposited, a choice which is not available to those filing paper returns.

Last year the number of returns filed electronically exceeded 2.3 million, and the upward trend is on track to continue. Of the more than three million returns filed so far this season, nearly two million, or 65 percent of them, have been filed electronically.

Taxpayers who need help completing their returns may contact the Division of Taxation’s Customer Service Center by calling 609-292-6400. They may also visit one of the Division’s Regional Offices located throughout the State. Division of Taxation employees will be available at each regional office to answer questions, assist with return preparation, accept completed tax forms, or supply blank forms. The Treasurer also reminded taxpayers who owe tax not to overlook the advantages of making their payments electronically. “You can file now and pay at any time until midnight on April 15th,” Rousseau said. New Jersey’s electronic payment methods include electronic check (e-check) and credit card. There is a credit card convenience fee of 2.49% paid directly to Official Payments Corporation based on the amount of the tax payment.

Taxpayers who need more time to file their returns can request a six-month extension of time to file. Extension requests can be submitted online through the Division of Taxation’s Web site ([www.state.nj.us/treasury/taxation/online.htm](http://www.state.nj.us/treasury/taxation/online.htm)) or by mail using the traditional paper form, Form NJ-630, Application for Extension of Time to File New Jersey Gross Income Tax Return, which can be printed from the Division of Taxation’s Web site. However, at least 80% of a filer’s actual New Jersey income tax must be paid by April 15 in order to receive an extension. Mailed extension applications must be postmarked on or before Tuesday, April 15, 2008; online extension requests can be submitted until midnight on April 15. Anyone making a payment of tax due with an online extension must pay by e-check or credit card.

Taxpayers who apply for an automatic extension of time to file their Federal returns may receive an extension for their New Jersey returns by including a copy of the Federal application when they submit their New Jersey income tax returns, provided they meet all other requirements (including the requirement that at least 80% of the actual New Jersey income tax liability be paid on or before April 15). Taxpayers who file for a Federal extension but also need to make a payment of New Jersey tax by the April 15 due date must submit Form NJ-630 with that payment or file and pay online.

“Taxpayers must remember that an extension of time to file an income tax return is *not* an extension of time to pay the tax due under the Gross Income Tax Act,” Rousseau explained. “Penalties and interest are imposed whenever tax is paid after the due date.”
