19.	Provide details of any integrity issues/findings	Documentation was not provided by the Construction Contractor to evidence compliance with the Buy America Act. On June 30, 2023, RSM US LLP notified New Jersey Transit Internal Audit officials of a potential issue related to compliance with the Buy America Act. We requested that the contractor provide submittal packages including evidence of certifications, audits, or other documentation showing compliance with Buy America requirements. Although submittal packages were provided for each item, the documentation did not include evidence that products were of domestic manufacture or origin.	NJT Response: Upon notification by the IOM RSM of a potential Buy America Act issues with contractor DMR, NJ TRANSIT took steps to assist DMR in providing relevant information. DMR provided all documents in their files, as requested by RSM. NJ TRANSIT confirmed DMR provided the requisite certification to abide by the Buy America Act and the General Provision of the contract terms include the Buy America provision. NJ TRANSIT scheduled a meeting with RSM to determine how DMR can further satisfy the inquiry or alternatives sources where the requested information can be obtained.
