During the quarter, the IOM renewed previous requests for various construction submittal documents, such as Site Safety Plans. NJT Capital Programs ("CP") informed the IOM that the documents will not be available until the construction phase of the contract begins, which it estimates will occur on April 1, 2024; during related correspondence, the Monitor learned on December 12, 2023 of a change made to the Project Manager of the Phase II Design-Build Contractor approximately one month prior due to lack of responsiveness from the prior Project Manager. The Monitor conducted a meeting with CP and Project Management, a subset of CP, on December 22, 2023 to discuss project status of the IOM Phase II scope and instructions for obtaining a schedule of Design-Build Contractor invoices. The IOM prepared requests for two Design-Build Contractor invoices and the estimated sitework start dates for each of the six worksites under IOM Phase II on December 26, 2023.</p> <p>TA also revised its preliminary budget by IOM Phase allocation based on information provided by CP relative to IOM Phase III.</p>
