

# **OREA EXPLAINS:** New Jersey Veterans Benefits

### COMBAT PAY TAX EXEMPTION

Beginning in tax year 2021, New Jersey made combat pay completely tax exempt. If your combat pay is exempt from federal income tax, it should not be reported on a State Income Tax return. U.S. military pension and survivor's benefit payments are also not taxable.

### WOUNDED WARRIOR CAREGIVER CREDIT

The Wounded Warrior Caregivers Relief Act provides a tax credit to qualified family caregivers who take care of a military service member who has a disability sustained from their service on or after September 11th, 2001.The annual credit is equal to 100% of the federal veteran disability compensation, or \$675, whichever is less.

# GOLD STAR COUNSELING CREDIT

Mental health care professionals who provided counseling through the Gold Star Family Counseling program can take a credit to reduce tax due, equal to the amount documented annually by the Department of Military and Veterans' Affairs for the Gold Star Family Counseling Program.<sup>2</sup>

#### With Gratitude

The Department of the Treasury and the entire State of New Jersey sincerely value the sacrifices of our military veterans and active service members. While we can never fully repay our gratitude, we are working diligently to make life easier for the military community, including easing financial burdens through tax benefits and other programs, and providing services to help ease the transition to civilian life.



In tax year 2021, New Jersey provided **\$183,974,824** in tax benefits to veterans through five different programs, including the \$6,000 income tax exemption for veterans, which was claimed by 152,029 veterans<sup>1</sup>. More than 140,000 veterans claimed the \$250 property tax exemption in tax year 2021, and 13,976 veterans were credited with a 100% disabled property tax exemption.<sup>3</sup>

## **VETERAN OWNED BUSINESSES**

In spring of 2021, State Treasurer Muoio waived the cost of certification for small, minority, women, veteran, and disabled veteran-owned businesses, making it easier for Veteran and Disabled Veteran business owners to market themselves as certified businesses to government and private companies seeking contracts for goods, services and construction. Through a concerted effort by the Murphy Administration to increase outreach, the number of veteran-owned businesses registered to do business with the State has increased five-fold between 2020 and 2022, and the number of disabled veteran-owned business registrations has increased by more than 800%.



# **OTHER STATE BENEFITS AND RESOURCES**

- The NJ Department of Military and Veterans Affairs <u>assists veterans with crucial</u> <u>issues</u> pertaining to employment, education, burial, counseling, housing, social and medical services, in addition to providing trained and ready forces prepared for rapid response to a wide range of civil & military operations.
- The NJ Department of Education offers expedited <u>educator-certification application</u> review for veterans and active-duty military spouses. The Department also offers a certification fee waiver to those veterans & active-duty military spouses for initial applications.
- NJ TRANSIT offers discounts for military personnel, their families, and veterans, as well as career opportunities for veterans through the <u>Edge4Vets</u> program.
- The NJ Housing and Mortgage Finance Agency programs for first-time homebuyers and down payment assistance can be utilized with the <u>VA's home loan benefit</u>.
- The NJ Civil Service Commission has a <u>Veteran's Preference</u> in employee selection that places qualified veterans at the top of an open competitive employment list.
- The NJ Department of Corrections' <u>Office of Transitional Services</u> provides prerelease interviews to determine eligibility for Veterans Benefits and Social Security Disability Insurance/Supplemental Security Income.
- The NJ Department of Agriculture's <u>Homegrown by Heroes</u> program is a marketing program that provides farmer veterans with a distinctive label to promote their agricultural products.
