The actions taken during closed session are anticipated to become available to the public at the conclusion of the meeting and are posted on the Division of Pensions and Benefits' website within a reasonable time; except all personal information pertaining to an individual shall be redacted of all identifying information unless the member waives his privacy interest and consents in writing to disclosure in accordance with HIPAA".
