Do you have employees who are looking for information about retirement?

The NJDPB has upcoming **in-person Retirement Planning Seminars and live online webinars** scheduled for members of the Public Employees' Retirement System (PERS), Teachers' Pension and Annuity Fund (TPAF), or Police and Firemen's Retirement System (PFRS). **Seats are still available for summer sessions!**

In-person Seminars are available at locations across the state. Live Webinars cover the same information as our seminars but can be attended from your own computer without the need to travel.

Designed for employees who are planning for retirement, **retirement seminars** and **webinars** provide a step-by-step look at the retirement process. We explain retirement benefits, beneficiary options, group life insurance, and how to submit the retirement application online using MBOS. Retirement eligibility, purchase, loan repayment provisions, and the taxability of pension are explained along with a brief discussion of State Health Benefits Program and School Employees' Health Benefits Program coverage in retirement. Seminars and Webinars conclude with a question and answer period.
