What is the overall deductible ?	\$0 – Deductible does not apply	First day, first dollar coverage. You do not have to meet a <u>deductible</u> amount before this plan begins to pay for covered services you use. See the chart starting on page 2 for how much you pay for covered services.
Are there services covered before you meet your deductible ?	Yes. All eligible services.	This plan covers items and services that do not require a <u>deductible</u> to be met.
Are there other deductibles for specific services?	No	You don't have to meet <u>deductibles</u> for specific services, but see the chart starting on page 2 for other costs for services this plan covers.
What is the out-of-pocket limit for this plan ?	Yes. For in-network \$2,500 out of pocket maximum.	The <u>out-of-pocket limit</u> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses.
What is not included in the out-of-pocket limit ?	Premiums, balance-billed charge for a Medicare provider who does not accept Medicare Assignment, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a network provider ?	Yes, but not required as long as the provider accepts Medicare. Do you need a referral to see a specialist ?	No except for member residing in California and Illinois.	You can see the <u>specialist</u> you choose without a referral unless you are a member who resides in California and Illinois.

Your Rights to Continue Coverage:

If you lose coverage under the plan, then, depending upon the circumstances, Federal and State laws may provide protections that allow you to keep health coverage.
