What is the overall deductible?	\$0	See the Common Medical Events chart for your costs for services this <u>plan</u> covers.
Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> is covered before you meet your <u>deductible</u> . # Does this plan provide Minimum Essential Coverage? Yes
