The Pilot Program will consist of the appointment of three (3) private third-party vendors as a result of this RFQ, to administer the skills tests for CDLs and endorsements, with one third-party vendor each to be located in the northern, central, and southern regions of the State. The Pilot Program shall be for the period of one (1) year.
