WHEREAS, pursuant to Article II, Section 1 of the New Jersey Trust Fund Authority's By-laws, the meetings of the Authority shall consist of an Annual Meeting, Special Meetings and Emergency Meetings; and

WHEREAS, the Authority (the "Authority") desires to adopt an annual notice of meetings consistent with the requirements of the "Senator Byron M. Baer Open Public Meetings Act," N.J.S.A. 10:4-6 et seq.; and

WHEREAS, the Authority has determined that all notices for any annual, special or emergency meeting will be posted in the main entrance of the New Jersey Department of Transportation's Headquarters; emailed and mailed to *the Courier Post*, *the Press of Atlantic City*, *the Star Ledger*, *the Times of Trenton* and the *Trentonian*; filed with the Secretary of State; and posted on the Authority's website.

NOW, THEREFORE BE IT RESOLVED BY THE MEMBERS OF THE NEW JERSEY TRANSPORTATION TRUST FUND AUTHORITY, AS FOLLOWS:

Section 1. The recitals are incorporated herein by reference as if set forth at length herein.

Section 2. The Authority hereby adopts the schedule of meetings attached hereto as Exhibit A and incorporated herein by reference.
