Family Advocate Program Now Up and Running

The New Jersey Family Advocate Program ("FAP") is now operational and assisting families and individuals directly impacted by the September 11 Attacks.

Created by Governor James E. McGreevey through Executive Order No. 5 as the replacement for the Family Assistance Center which closed March 22, FAP is designed to meet the long-term needs of families who lost loved ones and individuals who were physically injured in the Attacks. Through individualized attention by experienced and trained family advocates, the program assists families in gaining hassle-free access to resources including charitable and private benefits, legal, financial and mental health services, scholarship programs, job training and skill enhancement programs.

The FAP is run by New Jersey Family Advocate Program Management, Inc. ("NJFAM"), a non-profit corporation established by Executive Order No. 5, under the guidance and supervision of the Governor's Office of Recovery and Victim Assistance. NJFAM is using the services of the United Ways of New Jersey to administer the FAP.

Financial Planning Seminars Set for April

Governor McGreevey Waives Tuition at State Colleges for 9/11 Victims' Families

Governor James E. McGreevey has signed an Executive Order requiring State colleges and universities to waive tuition for the children and spouses of the September 11 Attack victims. The Executive Order is retroactive and provides that tuition for the Fall 2001 and Spring 2002 semesters be waived as well as for future terms.

The Executive Order directs State colleges and universities as well as the New Jersey Institute of Technology to immediately refrain from charging tuition to victims' family members until the World Trade Center Scholarship Program becomes operational.

The law establishing the scholarship program calls for the creation of a 10-member board, subject to Senate approval, to raise and distribute funds for the victims' families. One designee, William Barham, who lost his brother-in-law on September 11, has been confirmed by the Senate. Barham is from Monmouth Beach. The remaining nine designees will be subject to confirmation on or after May 9 when the Senate resumes session. The designees, most of whom lost a loved one on September 11, are:

Horizon Cares Victims' Relief Fund

New Jersey residents whose health care coverage was affected due to the loss of a family member in the September 11 Attacks may be eligible for financial assistance to continue medical and/or prescription coverage through the Horizon Cares Victims' Relief Fund created by Horizon Blue Cross and Blue Shield of New Jersey. Applications to the Fund require a death certificate; current COBRA notice or health insurance premium bill, and proof of the victim's final residence. Princeton Psychologists Run Weekly Support Group Meetings for Families of 9/11 Victims

Princeton psychologists Ruth B. Goldston, Ph.D. and Brian G. McDonald, Psy.D., are currently leading weekly support group meetings for families of September 11 victims. The meetings, also run by Kathy Daniels Tedeschi, whose husband was killed in the bombing of Pan Am flight 103 over Lockerbie, Scotland, are held for family members from Mercer, Somerset and Middlesex counties as well as Bucks County, Pa. The meetings take place at the Jewish Center in Princeton on Wednesday evenings at 7:30 p.m.

Meetings last up to 2½ hours and include large- and small-group discussions of issues faced by participants as well as occasional presentations by community groups and professionals. Participants include widows, widowers, parents, siblings and fiancees of loved ones lost in the September 11 Attacks.

New York officials have announced the opening of a Family Room at One Liberty Plaza where families of September11 victims may go to observe the World Trade Center site in a private setting. Located on the 20th floor of One Liberty Plaza, New York, N.Y., the room, which has a children's area, was established exclusively for the families of September11 victims and replaces the outdoor family

platform on Liberty and West streets.

Principles and Blueprint Established for Renewal at World Trade Center Site

The Lower Manhattan Development Corporation has announced it has established a set of "principles for action" that will guide the development of the World Trade Center site and created a "Blueprint for Renewal" at the site, including establishing a memorial honoring the victims of the terrorist Attacks and coordinating mass transit services to provide a coherent integration between lower Manhattan and the rest of the city and region.

The LMDC will work with the Port Authority and numerous partners in the public and private sectors to chart a course for revitalizing lower Manhattan.

The principles announced include:

- creating a memorial honoring the victims of the terrorist Attacks while reaffirming the democratic ideals that came under attack on September 11.
- making decisions based on an inclusive and open public process.
- assisting the rapid revitalization of lower Manhattan, in a manner that does not preclude desirable future development plans.
- coordinating and encouraging infrastructure improvements that will trigger the private investment needed to sustain and enhance lower Manhattan
