ORDINANCE #1-0-06

AN ORDINANCE TO RENAME HIGHLAND AVENUE AS "WARREN HAGSTROM BOULEVARD"

WHEREAS, Warren Hagstrom was born and raised in the Borough of Wanaque, settling in his hometown to raise his own family; and

WHEREAS, Warren Hagstrom served on the Wanaque Board of Education and the Wanaque Borough Council before being elected Mayor in 1990; and

WHEREAS, Warren Hagstrom created a vision for our community, which led to the reconstruction and redevelopment of Ringwood Avenue, preserving open space at the Gallo property on Townsend Road and the Wanaque Manor tract on Jefferson Street and the Boulevard; and most importantly, the construction of a 755 unit active adult community known as the Wanaque Reserve by Del Webb; and

WHEREAS, Warren Hagstrom had the joy of seeing the Wanaque Reserve being started, visiting the site every day to monitor its progress; and

WHEREAS, on November 5, 2005, Warren Hagstrom left this life, leaving a better community for all of our residents; and

WHEREAS, The Mayor and Borough Council feel that a lasting tribute to Warren Hagstrom is to re-name Highland Avenue as "Warren Hagstrom Boulevard" which will include all of the addresses of the Wanaque Reserve by Del Webb.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF WANAQUE AS FOLLOWS:

- 1. That the Borough Engineer and the Borough Tax Assessor be and are hereby authorized and directed to amend the official map and the official Tax Map of the Borough of Wanaque to rename Highland Avenue from Ringwood Avenue to its extension to the Wanaque Reserve by Del Webb as Warren Hagstrom Boulevard.
- 2. That the Borough Clerk be and is hereby authorized and directed to amend the Borough Code in all places to reflect the change of name from Highland Avenue to Warren Hagstrom Boulevard.
- 3. That the Borough Clerk be and is hereby authorized and directed to file a certified copy of this Ordinance with the Passaic County Registrar of Deeds and Mortgages, the Passaic County Superintendent of Elections, the New Jersey Secretary of State, the Wanaque Postmaster and any other County, State or Federal agency which requires a notification of a street name change.

Any ordinance inconsistent with this ordinance is hereby repealed, but only to the extent of such inconsistencies.

This ordinance shall take effect upon final adoption and publication according to law.
