

NJSA 19:61 – 9: AUDITS OF ELECTION RESULTS

Audit Date November 20th 2024

The Hudson County Board of Elections (HC BOE) performed a post- election audit consistent with the provision of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office.

The HC BOE conducted a hand to eye count of the vote – verifiable paper records for the, November 5th 2024 General Election for the offices of the US President, All Congressional House Representatives, US Surrogate and local offices where applicable.

Pursuant to the statute “the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot.”

Audit units included: vote by mail ballots by municipality/ward, provisional ballots by municipality/ward, and early voting paper ballots. In total 3,225 audit units were created.

There are only one Congressional Districts in Hudson County for this General Election: 8th, 9th, & 10th Congressional

As provided for in the statute, the following audit units were randomly selected for audit on November 20th , 2024 at 12pm.
