### JOB DESCRIPTION

The Police & Firemen's Retirement System of NJ (PFRSNJ) is seeking a Senior Investment Analyst. The Senior Investment Analyst will report to the Heads of Asset Classes and will work directly with both senior leadership and investment analysts. This individual is responsible for researching, sourcing, selecting, and investing in external investment managers and funds. This individual may be a member of one or various Asset Class Committees and this position will include all responsibilities relating to membership on those committees. Conduct research through investment databases, quantitative analysis, conference calls, on-site meetings, and attending conferences to create investment opinion documents. Opinion documents will be created for all investment advisors, funds, and investments with their assigned asset class. Opinions will include all necessary recommendations.

This position will be a member of all relevant Asset Class Committees. This position will include all responsibilities relating to membership on the various committees. This individual will be responsible for monitoring all output by both junior staff assigned to those asset classes. For public markets, this individual will conduct public RFQ processes as needed to identify investment advisors for retention. For private markets, in conjunction with the asset class consultant, general consultant, and industry contacts/publications, maintain an investment pipeline of available funds in market. Follow policy/procedures for evaluating the RFQ responses and investment pipeline. Create investment thesis for Investment Advisors and Fund Commitments. Including the alpha drivers for the strategy's relative return. Understanding the quantitative factors through Brinson and multifactor attribution, regression analysis, and understanding the advisor's modeling process (DCF, DDM, Multiple Analysis, etc.) as well as understanding the qualitative factors necessary for continued execution. Maintain regular communication with investment advisors/general partners and/or monitoring of assigned investments. Monitoring will include quarterly meetings, DDQ review, RFIs, and annual on-site meetings. Assist in ensuring daily compliance of the asset class. Ensure all trade approvals are reviewed and responded expeditiously so Investment Advisors may execute approved trades. Responsibility of maintaining PFRSNJ's relationships with investment advisors, general partner, consultants, and service providers within their assigned asset classes. Train Investment Analysts by providing input into their work and having them join meetings with external advisors. Performs other related duties as needed.

The standard workweek is Monday through Friday. This position may be eligible to participate in the Department's pilot telework program, which allows eligible employees to work remotely for up to two (2) days per week, as approved by management. The position offers a comprehensive benefits package including medical, prescription drug, and dental coverage, benefit leave, Pension, supplemental pension plan, tax saving programs, and paid holidays.

### POSITION REQUIREMENTS

**Education & Experience:**

Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester-hour credits are equal to one (1) year of relevant experience.

Ten (10) years of professional experience with a public or private organization as a practicing securities analyst involved with researching and monitoring corporate performance and preparation of detailed reports containing recommendations, three (3) years of which shall have been in a supervisory capacity. Three (3) years of this experience shall have been within the most recent ten (10) year period; including or supplemented by eighteen (18) semester hour credits in any one or combination of the following areas: accounting, finance, money and banking, statistics, economics, or investments.

-OR-

Possession of a bachelor's degree from an accredited college or university, including or supplemented by eighteen (18) semester hour credits in any one or combination of the following areas: accounting, finance, money and banking, statistics, economics, or investments; and six (6) years of the above-mentioned professional experience, three (3) years of which shall have been in a supervisory capacity. Three (3) years of this experience shall have been within the most recent ten (10) year period.

-OR-

Possession of a Master's degree from an accredited college in Business Administration (M.B.A.), Accounting, Finance, Economics or a related field; and six (6) years of the above-mentioned professional experience, three (3) years of which shall have been in a supervisory capacity. Three (3) years of this experience shall have been within the most recent ten (10) year period.

Experience involving retail investment and retail research will not be acceptable.

Experience as a registered representative for individuals is not acceptable for this position.

**Note:**

"Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.
