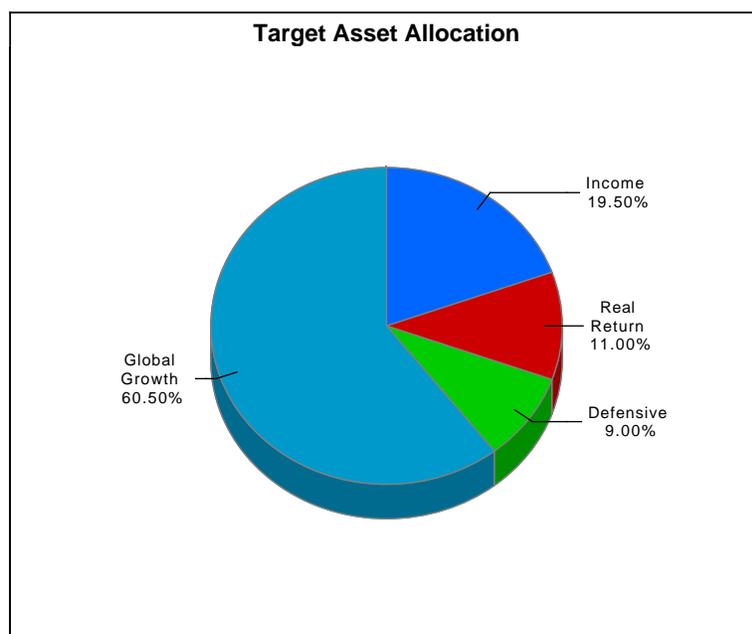
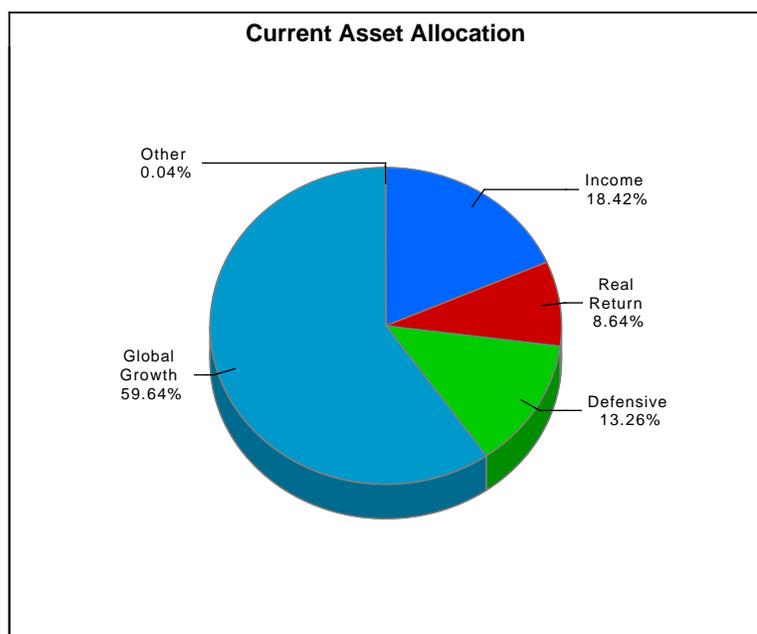

As of January 31, 2026**

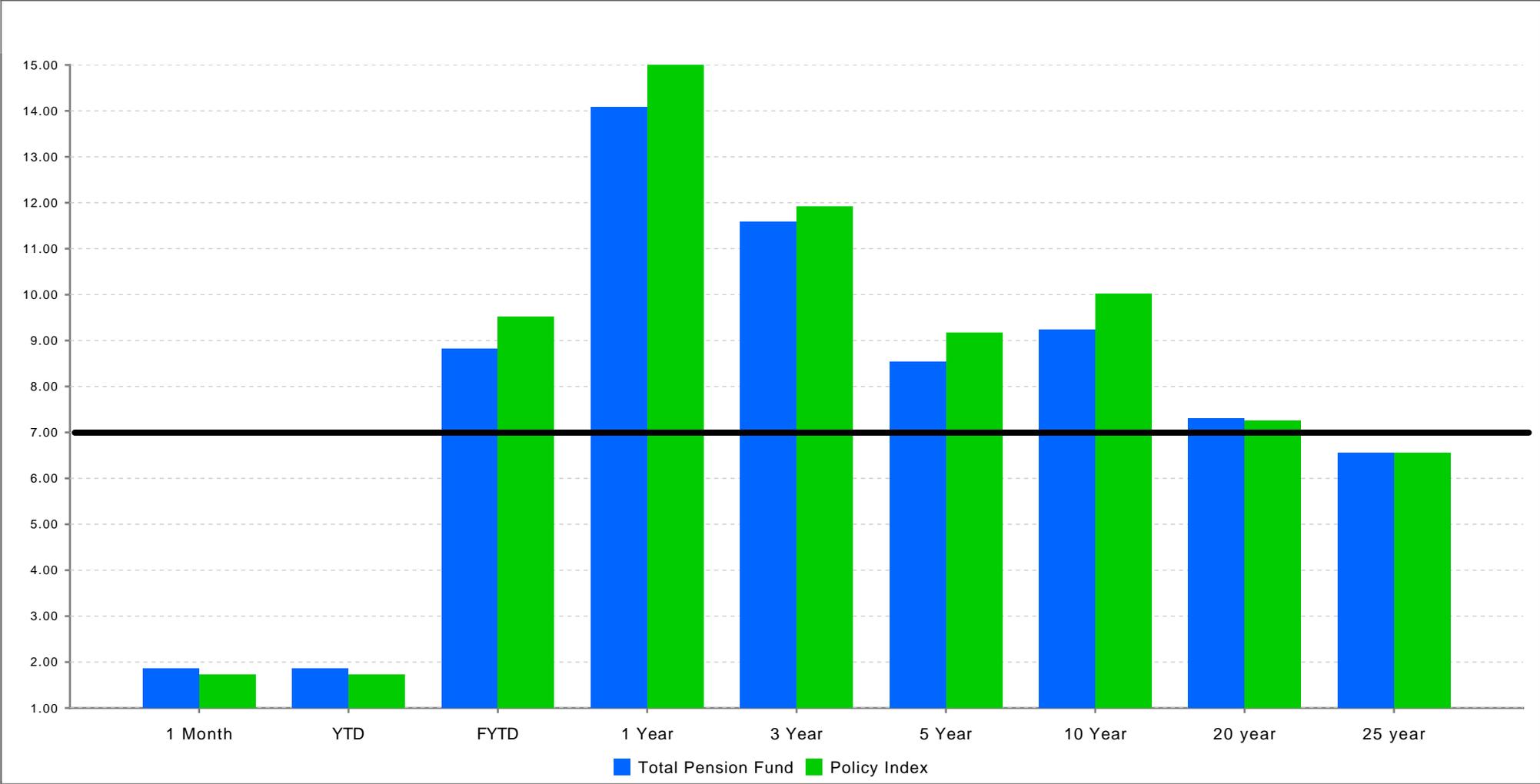

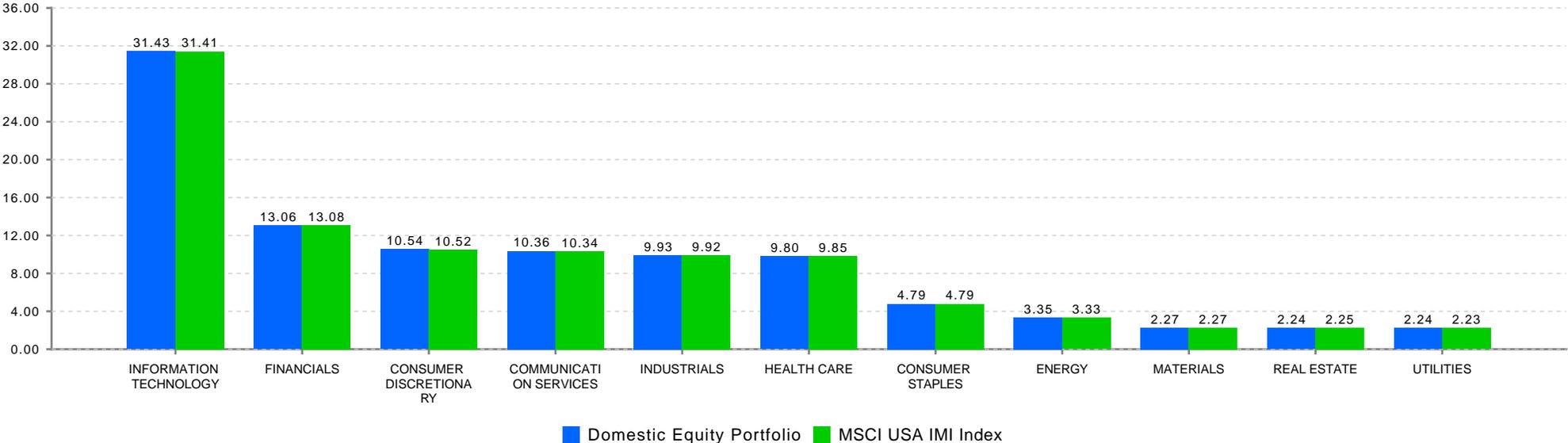

Sector Weightings****



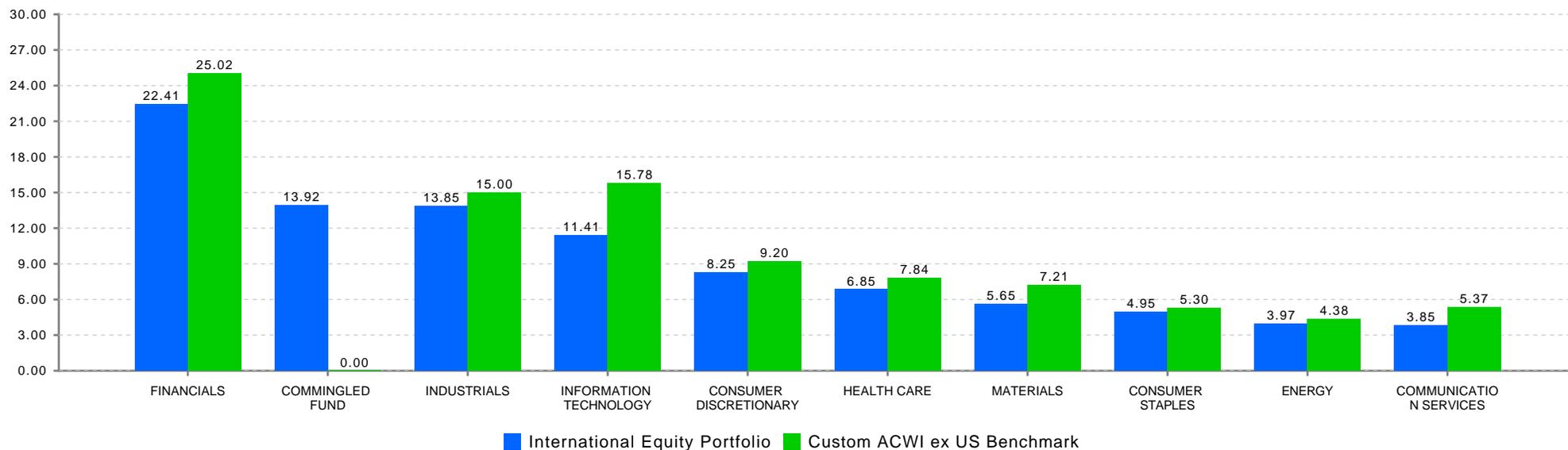

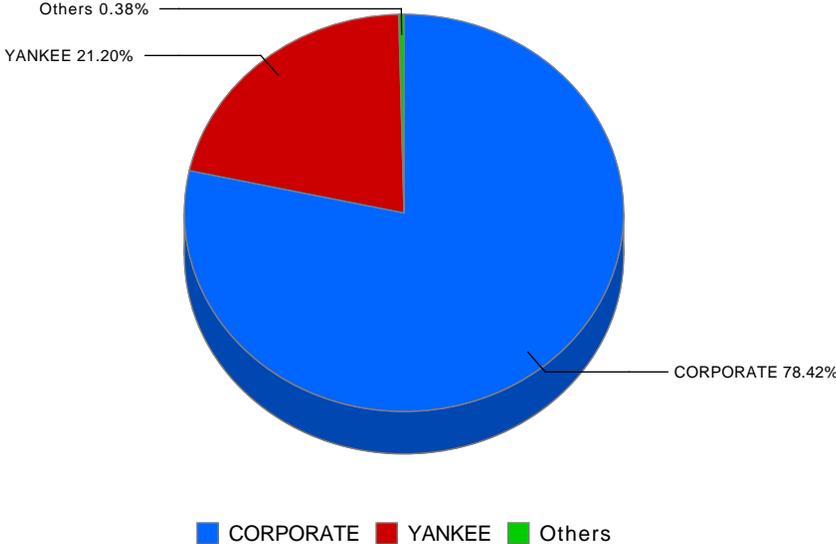

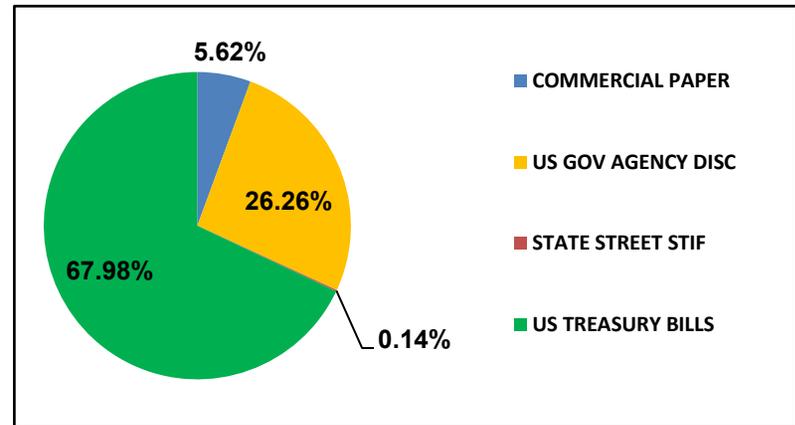
