The New Jersey Cannabis Regulatory Commission (CRC), acting under the authority of the New Jersey Cannabis Regulatory Enforcement Assistance and Marketplace Modernization Act, N.J.S.A. 24:6I-31, et seq. (Personal Act) and the Personal Use Cannabis Rules, N.J.A.C. 17:30, et seq. (Personal Rules) and the authority of the Jake Honig Compassionate Use Medical Cannabis Act, N.J.S.A. 24:6I-1, et seq. (Jake Honig Act) and the CRC Rules, N.J.A.C. 17:30A, et seq. (Jake Honig Rules), conducted an onsite inspection of The Botanist Dispensary's located in Egg Harbor Twsp. and Williamstown, NJ. The following is a summary of the findings:

On Fri. April 29, 2022, I conducted a review of Medicinal Patient and Adult Use Customer Sales utilizing the approved Botanist Seed to Sale internal management system (IMS), Bio Track. Acreage/CCF NJ had been approved to conduct Medicinal Patient and Adults Use Sales at The Botanist, Egg Harbor Township and The Botanist Williamstown Dispensary locations. As part of the agreement between the Cannabis Regulatory Commission and Acreage/CCF NJ LLC, 14 hours of Medicinal Patient only access was to be established at each dispensary.

The Botanist had set aside the following 14 hours of patient only access per week at their two dispensaries.
