The New Jersey Cannabis Regulatory Commission (CRC), acting under the authority of the New Jersey Cannabis Regulatory Enforcement Assistance and Marketplace Modernization Act, N.J.S.A. 24:6I-31, et seq. (Personal Act) and the Personal Use Cannabis Rules, N.J.A.C. 17:30, et seq. (Personal Rules) and the authority of the Jake Honig Compassionate Use Medical Cannabis Act, N.J.S.A. 24:6I-1, et seq. (Jake Honig Act) and the CRC Rules, N.J.A.C. 17:30A, et seq. (Jake Honig Rules), conducted a review of the Medicinal Patient and Adult Use Sales at the Ascend Rochelle Park Dispensary, Rochelle Park, N.J. The following is a summary of the findings:

On Fri. April 29, 2022, I conducted a review of Medicinal Patient and Adult Use Customer Sales utilizing the approved Acsend NJ internal management system (IMS), Leaf Logic. Ascend NJ had been approved to conduct Medicinal Patient and Adults Use Sales at Rochelle Park Dispensary location. As part of the agreement between the Cannabis Regulatory Commission and Ascend NJ, 14 hours of Medicinal Patient only access was to be established at the dispensary.

Ascend NJ had set aside the following 14 hours of patient only access per week at the Rochelle Park dispensary.
