Good Morning Theresa,

According to the Compassionate Curaleaf NJ Dispensary Operations Manual, the patient should be checked for dispensing limits in the NJ MMP Registry prior to the sale and upon completion of the sale. If proper procedures were followed this mistake should have been recognized before the Caregiver left the building. It is not necessary to take off an ounce of Ms. Owens allotment when her script renews. These errors are a violation of N.J.A.C. 8:64-9.1 ATC Policies, Procedures and Records, and N.J.S.A. 24:6I-10a Dispensing Amount.

Please provide a corrective action plan and training record to verify that the associate has been made aware of the error and retrained.
