**RESOLUTION 2023-106**  
**APPROVAL OF APPLICATION TO AMEND PERMITS OR LICENSES TO CHANGE**  
**THE BUSINESS NAME OF ALTERNATIVE TREATMENT CENTERS AND ADULT-**  
**USE LICENSE AWARDEES**

**WHEREAS**, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act,” (“the Act”) authorizes a process for receipt of applications and issuance of permits to operate Alternative Treatment Centers (“ATCs”) in the state of New Jersey; and

**WHEREAS**, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

**WHEREAS**, the regulations for medicinal cannabis provide a process at N.J.A.C. 17:30A-7.8 for amendments to an Alternative Treatment Center permit, including changes of the ATC’s name; and

**WHEREAS**, three (3) Alternative Treatment Centers have requested changes to each of their respective business names; and

**WHEREAS**, each of these three (3) Alternative Treatment Centers has followed the requirements set forth at N.J.A.C. 17:30A-7.8; and

**WHEREAS**, each of these three (3) Alternative Treatment Centers has followed the requirements set forth at N.J.A.C. 17:30A-7.1(b)(2) and have submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services with its amended business name; and

**WHEREAS**, the Commission is charged with implementing the provisions of the Act as well as P.L.2021, c.16, known and cited as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act”; and

**WHEREAS**, the regulations for personal-use cannabis provide a process at N.J.A.C. 17:30-9.2 for changes to an issued adult-use cannabis license or award, including changes of the business’s name; and

**WHEREAS**, the four (4) annual license awardees listed below have requested changes to

each of their respective business names; and

**WHEREAS**, each of these four (4) annual license awardees has followed the requirements set forth at N.J.A.C. 17:30-9.2; and

**WHEREAS**, each of these annual license awardees has submitted documentation of a valid Business Registration Certificate on file with the New Jersey Department of the Treasury, Division of Revenue and Enterprise Services with its amended business name;

**NOW, THEREFORE, BE IT RESOLVED** by the New Jersey Cannabis Regulatory Commission pursuant to N.J.A.C. 17:30A-7.8 and N.J.A.C. 17:30A-7.1(b)(2), concerning amendments to Alternative Treatment Center permit, as well as pursuant to N.J.A.C. 17:30-9.2, concerning changes of the business's name, the following Alternative Treatment Centers and adult-use cannabis annual license awardees are **APPROVED** to change their business names as proposed in their submission to the Commission:
