RESOLUTION 2023-163
APPROVAL OF APPLICATION TO CHANGE LOCATION: GTI NEW JERSEY, LLC

WHEREAS, P.L.2019, c.153, “Jake Honig Compassionate Use Medical Cannabis Act,” (“the Act”) authorizes a process for the receipt of applications and issuance of permits to operate Alternative Treatment Centers (“ATCs”) in the state of New Jersey; and

WHEREAS, P.L.2021, c.16, New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act (“the CREAMM Act”) authorizes a process for the receipt of applications and issuances of licenses to operate adult-use cannabis businesses in the state of New Jersey; and

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis and personal-use cannabis is vested in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to the Act and the CREAMM Act; and

WHEREAS, the regulations for medicinal cannabis provide a process at N.J.A.C. 17:30A-7.8 for amendments to an Alternative Treatment Center permit, including changes of the ATC’s location; and

WHEREAS, the regulations for personal-use cannabis provide a process at N.J.A.C. 17:30-9.2 for changes to a cannabis license, including changes of location; and

WHEREAS, the entity listed below has followed the requirements set forth at N.J.A.C. 17:30A-7.8 and N.J.A.C. 17:30-9.2, and has paid the requisite fees pursuant to N.J.A.C. 17:30A-7.10 and N.J.A.C. 17:30-7.17 for the amendment to its medicinal cannabis permit and Class 2 Cannabis Manufacturer license; and

WHEREAS, the entity listed below has provided a Land Development Ordinance from Hackettstown, approval of the entity’s application for minor site plan and conditional use approval from the Hackettstown Land Use Board, and a letter of support from the Mayor of Hackettstown, each demonstrating local support and land use approval and has provided evidence of site control through a lease agreement; and

WHEREAS, the entity listed below has maintained compliance with the Commission’s regulations for medicinal cannabis at N.J.A.C. 17:30A, et seq., and regulations for personal-use cannabis at N.J.A.C. 17:30, et seq., for its dual-use manufacturing facility and currently has no compliance issues; and

WHEREAS, approval of this entity’s application to amend its manufacturing permit and license and change its location to a new location in a municipality that has authorized medicinal cannabis is beneficial to the medicinal patient population and adult-use cannabis consumers near the new location;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.A.C. 17:30A-7.8, N.J.A.C. and 17:30-9.2, the following Expanded Alternative Treatment Center is **APPROVED** to change its manufacturing location as proposed in its submission to the Commission:

Amendments to the medical permit and adult-use cannabis license shall not be executed until GTI passes a final onsite assessment of the Hackettstown facility. GTI New Jersey, LLC shall not conduct any medical or adult-use cannabis manufacturing activities at the Hackettstown facility until it receives an amended medical permit or adult-use cannabis license authorizing GTI New Jersey, LLC to commence such activities.
