RESOLUTION 2023-172
APPROVAL OF RENEWAL APPLICATION FOR TESTING LABORATORY
LICENSE: NEW JERSEY CANNALYTICS, LLC

WHEREAS, the authority to regulate and enforce activities related to medicinal cannabis previously was vested in the New Jersey Department of Health (“the Department”), and now vests in the New Jersey Cannabis Regulatory Commission (“the Commission”) pursuant to P.L. 2019, c.153; and

WHEREAS, P.L.2021, c.16, known as the Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act, (“the Act”), provides the procedures for the licensing of testing laboratories; and

WHEREAS, the Commission approved to issue the following Testing Laboratory license at its May 24, 2022, public meeting:

WHEREAS, pursuant to N.J.A.C. 17:30-18.4(b), in order to renew its Testing Laboratory license, a Testing Laboratory shall adhere to the following:

1. A testing laboratory shall update and ensure the correctness of all information submitted in previous applications for a license or otherwise on file with the Commission.
2. A testing laboratory shall submit a copy of the most recent assessment from the accreditation body as required at N.J.A.C. 17:30–18.5(e).

WHEREAS, failure to provide correct and current up-to-date information is grounds for denial of application for renewal of the license; and

WHEREAS, the above-listed Testing Laboratory licensee provided the requisite confirmation that all information submitted in previous applications for a license, or otherwise on file with the Commission, remains accurate or has otherwise been updated, and has submitted copies of the most recent assessments from the accreditation body as required at N.J.A.C. 17:30-18.5(e), and the Commission has determined that the Testing Laboratory is currently in compliance with the Act and the governing regulations regarding its operations concerning cannabis or cannabis items; and

WHEREAS, the Commission has determined that a complete and accurate renewal application was submitted for the above license;

NOW, THEREFORE, BE IT RESOLVED by the New Jersey Cannabis Regulatory Commission pursuant to N.J.S.A. 24:6I-18 and N.J.A.C. 17:30-18, the following Testing Laboratory has satisfied the requirements set forth under the law and regulations and the Commission has determined to renew the entity’s Testing Laboratory license as set forth below, pending payment of the requisite renewal fee pursuant to N.J.A.C. 17:30-7.17(d)(22):
