Claimant appealed the decision of the Appeal Tribunal holding a disqualification of benefits for leaving work voluntarily without good cause attributable to the work. **(This case was erroneously placed on the Agenda of October 18, 2023)**

ACTION: BOARD VOTED TO REVERSE THE TIMELINESS OF THE APPEAL AND REMAND THE MATTER TO THE APPEAL TRIBUNAL FOR TESTIMONY AND A DECISION ON THE MERITS.
