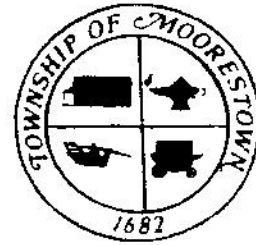

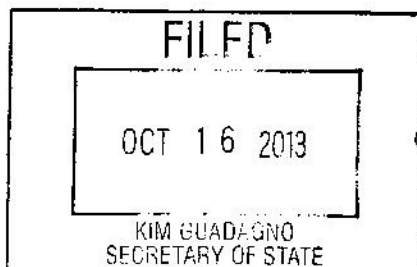

ORDINANCE NO. 24-2013

AN ORDINANCE REPEALING ORDINANCE 16-2013 ENTITLED "AN ORDINANCE OF THE TOWNSHIP OF MOORESTOWN REVISING PROVISIONS CONCERNING POLITICAL CONTRIBUTIONS AND EXPANDING REPORTING REQUIREMENTS TO ALL CONTRIBUTIONS AND AMENDING THE TOWNSHIP CODE"

WHEREAS, for the reasons set forth therein, the Township Council of the Township of Moorestown adopted Ordinance 16-2013 on August 19, 2013; and

WHEREAS, the Township Council wishes to repeal Ordinance 16-2013.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Moorestown, County of Burlington, State of New Jersey that:

- Section 1: Ordinance 16-2013, adopted on August 19, 2013 by the Township Council of the Township of Moorestown is hereby repealed in its entirety.
- Section 2: This Ordinance shall be filed by the Township Clerk with the Secretary of State in compliance with N.J.S.A. 40A:11-51(c).
- Section 3: Severability and Effectiveness Clause: If any sentence, paragraph or section of this ordinance, or the application thereof to any persons or circumstances shall be adjudged by a court of competent jurisdiction to be invalid, or if by legislative action any sentence, paragraph or section of this ordinance shall lose its force and effect, such judgment or action shall not affect, impair or void the remainder of this ordinance.
- Section 4: Effective Date: This ordinance shall become effective twenty calendar days from the second reading of the ordinance and adoption by the Township Council of the Township of Moorestown.
